There must be four (4) contestants signed up prior to March 1 to have a Championship.

**PERFORMANCE ORDER AND APPEARANCE** All contestants should be dressed appropriately (suit & tie for gentleman, business attire for ladies). Contestants will compete in reverse order of their registration. First to register is last to compete, last to register is first to compete. Contestants will be taken to a waiting area until their number is called to go on the stage. Any contestant not in the waiting area when their number is called will receive a ten (10) point deduction on their score and will appear at the next opening as directed by the MC.

**CONTEST PROCEDURES** All contestants are asked to bring two (2) items to be sold in the preliminary round. Items will be provided for a finals round. All finalist will be asked an interview question during the finals round of competition. A sample of the score card will be provided at the mandatory rules meeting. Score cards will be mailed to the contestants within one (1) week of the competition.

**FINALIST** The finalist will be chosen by their preliminary score totals as follows:

- Five (5) or less contestants there will be no final round the winner will be determined by highest score in the preliminary round.
- Nine (9) or less contestants there will be five (5) finalist
- 10-15 contestants there will be five (5) finalist
- 16 + contestants there will be eight (8) finalist

#### JUDGES AND JUDGING | There will be five (5) judges for the contest. Each judge will score in all categories.

The categories scored: Introduction; Initial Command; Appearance; Voice Control (clarity, rhythm and speed of chant); Overall Command; Accuracy; Salesmanship; Ambassador. All scores will count!
